Property Flipping Policy	 Properties resold 90 days or fewer following the date of acquisition by the seller are not eligible for FHA financing unless the loan meets the exceptions set forth in 4000.1 II.A.1.b.iv (A)(3). Properties resold between 91 and 180 days after acquisition require a second appraisal by a different appraiser if the resale price is 100% or more over the price paid by the seller when the property was 						

acquired.

Each borrower must have at least one credit score. See "No Credit Score" section for loans with no credit score.

Maximum CLTV is 105% if second mortgage is through a government-sponsored Down Payment Assistance Program (DAP)

Borrower must occupy the subject property as their Principal Residence for the past 12 months prior to case number assignment

Standard and High Balance

- An Identity-of-Interest Transaction is a sale between parties with an existing Business Relationship or between Family Members.
- Maximum LTV is 85%

Identity of Interest

 The maximum LTV percentage for a transaction where a tenant-landlord relationship exists at the time of contract execution is restricted to 85 percent.

Exceptions to the Maximum LTV:

- The borrower purchases the principal residence of another family member; or
- a Property owned by another Family Member in which the Borrower has been a tenant for at least six months immediately predating the sales contract. Written evidence to verify occupancy and rental payments is required.

Federal Debt

- Borrowers with delinquent Federal Tax Debt are ineligible.
- Tax liens may remain unpaid if the Borrower has entered into a valid repayment agreement with the federal agency owed to make regular payments on the debt and the Borrower has made timely payments for at least three (3) months of scheduled payments. The borrower cannot "prepay" scheduled payments in order to meet the required minimum of three months of payments.
- The Mortgagee must include the monthly payment amount in the agreement in the calculation of the Borrower's Debt-to-Income (DTI) ratio.

Refinance Seasoning

- the borrower has made at least six consecutive monthly payments on the loan being refinanced, beginning with the payment made on the first payment due date; AND
- the first payment due date of the new loan occurs no earlier than 210 days after the first payment due date of the loan paid off through the transaction.
- Borrower must occupy the subject property as their Principal Residence for the past 12 months prior to case number assignment on a cash-out refinance
- All loans must be run through AUS FHA Total Scorecard
- Purchase, Rate & Term and Cash-out

Reserves are equal to or exceed three months Mortgage Payments for 1-2 units and 6 months for 3-4 units. (Gift funds may not used for reserve requirements).

No Credit Score Requirements

Borrower's with no credit score's are permitted subject to the following restrictions:

- 30 yr Fixed, Single Family, Purchase only. High Balance loans are not eligible. • Borrower(s) must complete a Homebuyer Education course through a HUD Approved Counseling
- AUS Refer recommendation required. Loan must be manually underwritten according to HUD Handbook 4000.1, II.A.5 for credit, Income and Asset requirements.
- Ratio's 31/43 no exceptions
- Non-Occupant Co-Borrowers income may not be used in qualifications.

Agency and provide the signed certificate for each borrower.

• Reserves: Minimum 1 month PITI required. (May not be from a gift)

Ineligible Property Types

- Manufactured Housing
 - Working Farms
- Cooperatives
- Mobile Homes
