Identity of Interest	<ul style="list-style-type: none">• An Identity-of-Interest Transaction is a sale between parties with an existing Business Relationship or between Family Members.• Maximum LTV is 85%• The maximum LTV percentage for a transaction where a tenant-landlord relationship exists at the time of contract execution is restricted to 85 percent. Exceptions to the Maximum LTV: <ul style="list-style-type: none">• The borrower purchases the principal residence of another family member; or• a Property owned by another Family Member in which the Borrower has been a tenant for at least six months immediately predating the sales contract. Written evidence to verify occupancy and rental payments is required.		
Federal Debt	<ul style="list-style-type: none">• Borrowers with delinquent Federal Tax Debt are ineligible.• Tax liens may remain unpaid if the Borrower has entered into a valid repayment agreement with the federal agency owed to make regular payments on the debt and the Borrower has made timely payments for at least three (3) months of scheduled payments.
